### PUBLISHER'S NOTE

The purpose of this service is to keep subscribers up-to-date with current legislation (Public Bills only) as it is passed by the Ontario Legislature.

**Part I** lists the Acts that have received Royal Assent during the current calendar year. The Bill number and chapter number of each Act are indicated, as well as the date on which each Act comes into force. An Act may come into force in whole or in part on the date it receives Royal Assent, or on a date to be proclaimed by the Lieutenant Governor in Council. Proclamations issued during the current calendar year for Acts from a previous year, are listed separately in Part IV.

When a group of Bills receives Royal Assent on the same date, they are set out separately in alphabetical order, so that they may be identified quickly. However, the Bills themselves should be integrated into the binders in **chapter sequence**.

**Part II** is a concordance that lists the Bills by Bill number.

**Part III** lists in alphabetical order all Acts contained in R.S.O. 1990 and all Acts passed during subsequent years that were not proclaimed in force as of the date set out in the heading at Part III.

**Part IV** lists alphabetically all Acts or parts of Acts passed in previous years that were proclaimed in force during the current calendar year after the date set out in the heading at Part III.

**Note:** Each release is cumulative for the year and includes all information contained in the year's previous releases. When received, a release should be inserted at the front of the binder and the year's previous release should be discarded. **Bills are supplied in this service only after they have received Royal Assent.**

*Act came into force on the day it received Royal Assent.*  
Supply Act, 2020 (Bill 181) . . . . . c. 2  
*Act is deemed to have come into force on April 1, 2019.*
