• Part IX: Rate of Speed - Nature of Offence — The 36-year-old accused pleaded guilty to careless driving causing death and careless driving causing bodily harm, after his vehicle had drifted into the oncoming lane of a two-lane highway. The court found the accused's driving record to be unremarkable, but noted his criminal record had included driving convictions. Consequently, the court imposed a sentence of 45 days' intermittent, to be followed by two years' probation and a two-year driving suspension: *R. v. Henry*, 2023 ONCJ 273, 2023 CarswellOnt 10156 (Ont. C.J.).

Updates to the Words & Phrases include judicial interpretations of the following terminology:

- Roadway *British Columbia* "[T]he portion of the highway that is improved, designed or ordinarily used for vehicular traffic, but does not include the shoulder": per Hughes J., at para. 100, in *Raber v. Romero*, 2022 BCSC 748, 2022 CarswellBC 1997 (B.C. S.C.).
- Standard Auto Policy New Brunswick "The Standard Auto Policy is a contract of indemnity between the insurer and its insured.... its primary purpose is not to "protect" third-party claimants": per LeBlond J.A. (Green and French JJ.A. concurring), at para. 18, in Cooperators General Insurance Company et al. v. Martin et al., 2022 NBCA 15, 2022 CarswellNB 176 (N.B. C.A.).
