About the Authors

Kenneth A. Manaster is Professor of Law, Emeritus at Santa Clara University School of Law, where he has specialized in environmental law. He served from 1973 to 1990 as a Member of the Hearing Board of the Bay Area Air Quality Management District and was Chairman of the Hearing Board from 1978 to 1989. He has been Visiting Professor of Law at Stanford Law School, Adjunct Professor of Law at Hastings College of the Law, Visiting Associate Professor of Law at the University of Texas, and a Visiting Scholar at Harvard Law School. He also has been a senior staff attorney with the Natural Resources Defense Council and is currently Senior Counsel to Pillsbury Winthrop Shaw Pittman LLP in San Francisco. From 1984 to 1987 he was Chairman of the Public Advisory Committee to the U.S. Environmental Protection Agency's Integrated Environmental Management Program study of toxic pollutants in the Santa Clara Valley. Prior to joining the faculty at Santa Clara in 1972, he was an Assistant Attorney General of Illinois, serving as Chief of the Northern Region for the Attorney General's Environmental Control Division. He earlier was an associate in the Chicago firm of Leibman, Williams, Bennett, Baird and Minow (now Sidley Austin LLP) and clerked for U.S. District Judge Bernard M. Decker. He is a graduate of Harvard College and Harvard Law School and studied in Peru on a Fulbright Fellowship. He is the author of numerous articles on environmental law and other subjects.
