REMOVE and **RECYCLE** the Title Page and Table of Contents from the front of Volume 3; and Uniform Commercial Code Article 9 on Secured Transactions, the Table of Laws and Rules, the Table of Cases, the Table of Key Numbers, and the Index from behind the corresponding tabs.

PLACE the new Title Page and Table of Contents in the front of Volume 3; and Uniform Commercial Code Article 9 on Secured Transactions, the Table of Laws and Rules, the Table of Cases, the Table of Key Numbers, and the
