Filing Instructions

Replacement Content for Volumes 4 and 5

RECYCLE the existing pages and supplements in Volume 4 and 5. **Retain** the binders and the tabs.

In Volume 4 (by Plitt, Plitt, Maldonado, and Rogers), **INSTALL** the **new** Table of Contents immediately behind the Table of Contents tab, the **new** Chapters 51-56 immediately behind the Chapters 51-56 tab, the **new** Chapters 57-60 immediately behind the Chapters 57-60 tab, and the **new** Chapters 61-65 immediately behind the Chapters 61-65 tab. **Retain** the Supplement tab at the very end of your binder.

In Volume 5, **INSTALL** the **new** Table of Contents immediately behind the Table of Contents tab, the **new** Chapters 66-71 immediately behind the Chapters 66-71 tab, the **new** Chapters 72-76 immediately behind the Chapters 72-76 tab, and the **new** Chapters 77-80 immediately behind the Chapters 77-80 tab. **Retain** the Supplement tab at the very end of your binder.

PLACE your complete revised **Volumes 4 and 5** on the shelf with your Couch on Insurance 3D set.

New Couch Table of Contents and June 2025 Supplement

For **ALL** volumes **EXCEPT** 4 and 5 and Volumes I-III of the 3 **FORMS** volumes:

REMOVE the **Table of Contents** from behind the Table of Contents tab at the front of the binder and recycle the pages. **REPLACE** it with a new Table of Contents showing a 6/2025 date in the footer.

REMOVE the existing December 2024 supplement from the back of the binder. **LOCATE** the new June 2025 counterpart for that particular

volume and **PLACE** that supplement behind the red Supplement tab at the back of the binder.

For **FORMS VOLUMES**, **REMOVE** the existing December 2024 supplement pages from behind the red supplement tab at the rear of each volume, and **INSERT** corresponding new June 2025 supplement pages in the rear of their respective volumes, behind the red Supplement tab in each of the three binders.
