Supplementary pamphlets should be shelved immediately following the corresponding main volumes; remove and recycle any corresponding pocket parts or supplementary material. Remove and recycle main volumes 4, 10A, 11A, 13 and 15 and any corresponding supplementary materials and shelve the new volumes 4, 10A, 11A, 13 and 15 in their place.
