Volume 12 covers the topic Workers' Compensation and includes Chapters 1 to 9, along with a Table of Laws and Rules, Correlation Table, and Index for the topic. Please note that for ease of handling, the materials in this shipment may be contained in more than one box.

Shelving Instructions

- REMOVE and RECYCLE all previous pocket parts to Georgia Jurisprudence.
- PLACE the new **2025-2026 pocket parts** inside the back covers of their respective volumes.
- REMOVE and RECYCLE the 2024-2025 Editions of the Finding Aids pamphlet and the General Index.
- PLACE the new **2025-2026 Editions** of the Finding Aids pamphlet and the General Index pamphlets, A to H and I to Z, on the shelf at the end of the numbered volumes to conclude the Georgia Jurisprudence set.
- REMOVE and RECYCLE the 2015 edition of Georgia Jurisprudence Volume 12.
- PLACE the revised **2025 Edition** of Georgia Jurisprudence Volume 12 on the shelf following Volume 11 and preceding Volume 13. As Volume 12 is shipping with the annual pocket parts, it contains a generic pocket part insert.
