For references to sections of the Transportation of Dangerous Goods Act, the short form TDGA will precede the section number. For references to sections of the Transportation of Dangerous Goods Regulations, only the section number will appear, or in the case of Appendix material, the Part and Appendix numbers will be noted.

For the material in the Interpretive Guide (Chapters 1 to 23), the indexing will be referenced to the chapter number and section "16:3".

For the material in the 2016 Emergency Response Guidebook the indexing will be referenced to the Numbered Guides (111 to 173) for the safety and emergency response. The acronym ERG will be utilized together with the Guide Number.
