Highlights:

- Variation of Parenting and Contact Orders—Material Change in Circumstances—Remarriage, Cohabitation and a New Family Unit; Change in Employment; Wishes of the Child—Remarriage, Cohabitation and a New Family Unit—Case Law—When the father's relationship ended with his common-law spouse, who had been the primary caregiver for the children, this constituted a material change of circumstances: M.A.F. v. J.C.F., 2021 BCSC 1447, 2021 CarswellBC 2342 (B.C. S.C.).
- Variation of Parenting and Contact Orders—Material Change in Circumstances—Parental Conduct and Health Affecting the Child—Case Law—New Brunswick—The father's refusal to acknowledge the children's issues and a need for increased therapy was a change in circumstances. The children exhibited signs of increased anxiety and expressed fear of being in their father's home. At the time of the divorce, the parties had agreed to follow a psychologist's recommendations. The father's current insistence that the children's counselling be terminated constituted a material change in circumstances, warranting a variation of the father's parenting time on an interim basis: J.B.-S. v. M.M.S., 2021 NBQB 96, 2021 CarswellNB 245, 56 R.F.L. (8th) 438 (N.B. Q.B.).
- Variation of Parenting and Contact Orders—Material Change in Circumstances—Parental Conduct and Health Affecting the Child—Case Law—Ontario—A material change of circumstances occurred where the children left the father's home due to conflict and an uncomfortable home environment; the father had locked out the children and had not attempted to contact them. The father's mental health was unpredictable, and the children had suffered abuse in his house. The court held that it was in the best interests of the children to vary the order to reflect the status quo, with the mother having sole decision-making authority and sole residence with the mother: V. v. V., 2021 ONSC 4380, 2021 CarswellOnt 8907 (Ont. S.C.J.)
