HOW TO USE THE ANNUAL CONSOLIDATED INDEX

The Annual Consolidated Index to the Regulations of Ontario is published in the spring of each year and contains a complete index to the R.R.O. 1990, the R.R.O. 1990 Supplement, as well as all regulations filed with the Ontario Gazette up to and including December 31st of the preceding year. The Annual Consolidated Index is supplemented on a monthly basis by the indexes provided in the Ontario Regulations Service. As the monthly indexes are cumulative and contain all regulations promulgated to date in the calendar year, the reader need only refer to the Annual Consolidated Index in conjunction with the most recent monthly index to obtain an overview of all Ontario Regulations currently in force.

The reader is cautioned that certain regulations not of general application have not been consolidated in the R.R.O. 1990. However, they remain in force until they expire or are revoked. These regulations are listed in the Schedule to the Revised Regulations of Ontario, 1990, which is found in the Schedule at page 773 of Volume 9 of the revised regulations. With respect to these regulations, only amendments promulgated after January 1, 1991, are included in the Consolidated Index. In the Consolidated Index a notation under the title of the given enabling Act will indicate that there are regulations under the Act that were not consolidated. Amendments to these unconsolidated regulations, made between January 1, 1981 and December 31, 1990, can be found in the 1991 Annual Consolidated Index for the previous edition of the Ontario Regulations Service (green binders).

Both the Annual Consolidated Index and its supplements provide various features not available in the periodic indexes published in the Ontario Gazette. Among these features are the following:

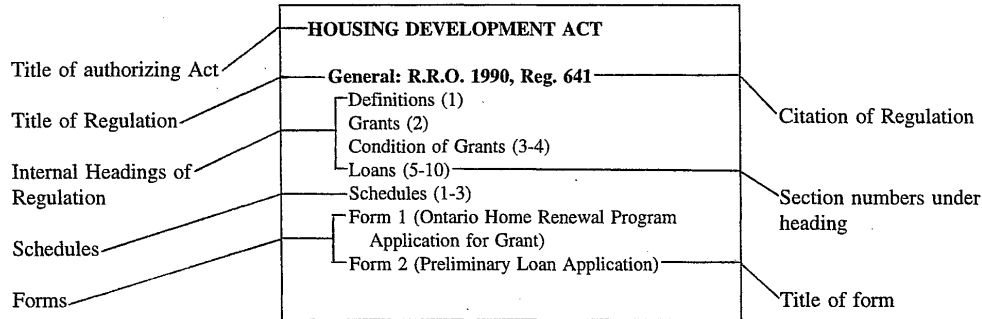
1. Where a regulation contains internal headings, these are reproduced in the Consolidated Index along with the titles of all schedules, tables and forms. In addition, the numbers of the regulation sections appearing under the individual headings are also reproduced. The reader is therefore provided with a better indication of the regulation's content. As headings, schedules, tables, etc. are amended, added to or deleted from the regulation, these changes will be indicated in the monthly indexes and incorporated into the following year's Consolidated Index.
2. Where a regulation is amended, in addition to a chronological listing of amendments, all amendments are listed under the section amended. Similarly, where new provisions are added to an existing regulation, these additions are also indicated under the relevant section number. Where an entire regulation has been revoked, the fact of the revocation is also noted.

The regulations contained in the index have been arranged alphabetically under the title of the authorizing statute. Note that the index does not list every Ontario statute, but only those pursuant to which regulations have been made.

The method of using the index is illustrated in the following examples.

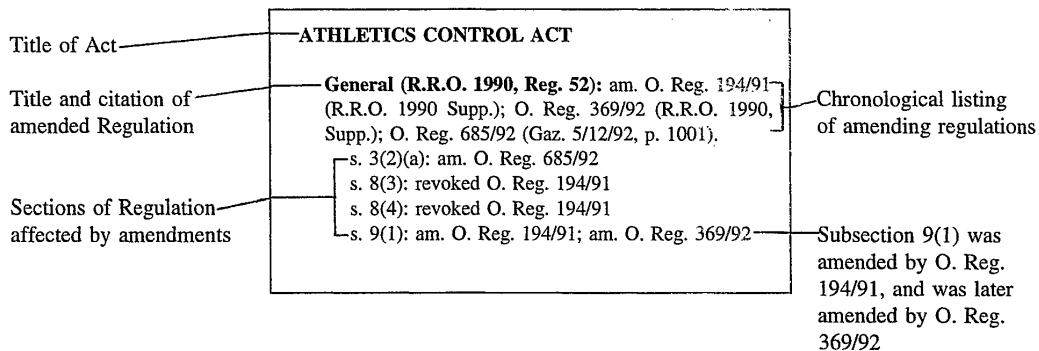
How to Use the Annual Consolidated Index

Example 1 — New Regulations



This example illustrates the entry for a regulation promulgated under the Housing Development Act. The name of the Regulation — “General” — is indicated on the second line of the entry and is followed by the regulation’s citation — “R.R.O. 1990, Reg. 641”. As the regulation contains both internal headings and forms, these are listed in a column format below the citation — “Definitions”, “Grants”, etc. The numbers of the sections appearing under each individual heading are indicated in brackets following the heading. For example, sections 5 through 10 of the regulation are found under the heading “Loans”. With respect to the forms, the title of the form is reproduced within the brackets found after the form number. For example, the full title of “Form 2” under the regulation is “Preliminary Loan Application”. As the regulation is amended and new headings, forms etc. are added, or old ones deleted, these changes are indicated in the monthly indexes and incorporated into the next Annual Consolidated Index issued.

Example 2 — Amended Regulations

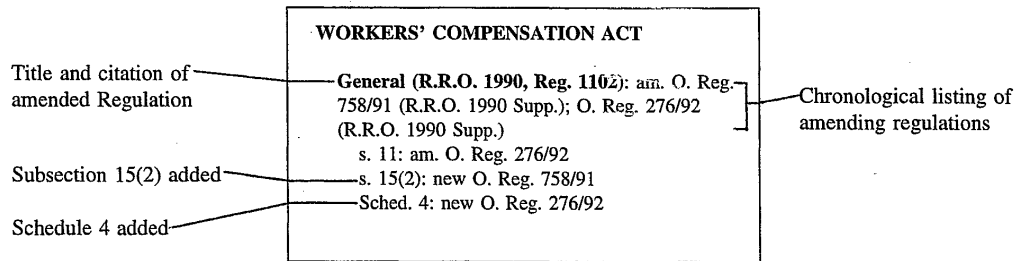


This example illustrates the entry for a regulation which has been amended. Again, the first line indicates the authorizing statute — “Athletics Control Act”. The title of the regulation which is being amended is found on the second line — “General” — followed by its citation enclosed in brackets — “(R.R.O. 1990, Reg. 52)”. This is followed by the abbreviation “am.” and the citations of the amending regulation, or regulations, including the Gazette date and page number. A list of sections affected by the amendments follows, in numerical order by section and subsection number. The reader is cautioned that the abbreviation “am.” means “amended by” in its broadest sense,

and covers both partial amendments and the entire re-enactment of a section or sections. To determine the exact nature of the alteration, the reader is advised to refer to the text of the amending regulation. The use of the “am.” abbreviation is to be distinguished from the use of the word “revoked” to indicate that a section has been revoked in its entirety and not replaced. Where a section has been amended by more than one regulation, the amending regulations appear in chronological order following the section number.

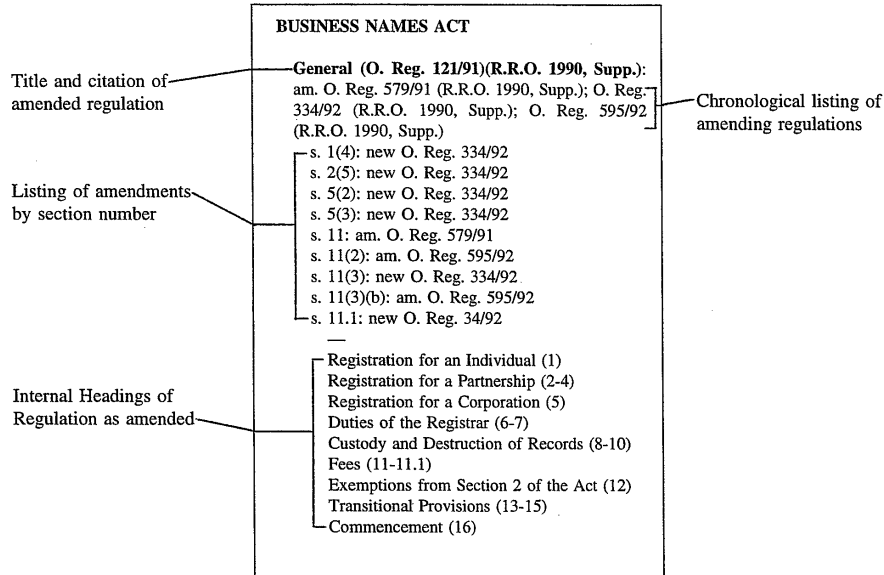
Example 3 — New Provisions Added on Amendment



In this example, a regulation promulgated under the Workers' Compensation Act has had a new subsection and a new schedule added to it by way of two separate amendments. The regulation which is being amended is R.R.O. 1990, Reg. 1102, entitled “General”. A totally new subsection — “s. 15(2)” — has been added by virtue of amending regulation O. Reg. 758/91. Subsequently a new schedule — “Sched. 4” — was added by virtue of amending regulation O. Reg. 276/92. The word “new” is inserted after a section number only where the section or subsection is totally new and did not formerly exist in the regulation. It is not used in the case where an existing section is entirely re-enacted. In this latter situation, the abbreviation “am.” is used.

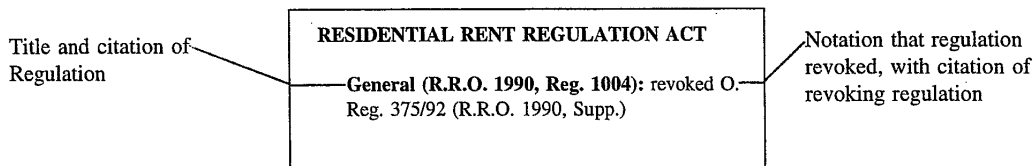

Example 4 — Amendments followed by Internal Headings of Regulations



In this example, Ontario regulation 121/91 (entitled “General”) under the Business Names Act, has been amended by three separate regulations, O. Reg. 579/91, O. Reg. 334/92 and O. Reg. 595/92. All of the sections that have been affected by these amendments are listed. The internal headings of the regulation, as they appear after amendment, are set out following the list of amendments to sections.

Example 5 — Revoked Regulations



In this example, regulation R.R.O. 1990, Reg. 1004 (entitled “General”) has been revoked and not re-enacted by regulation O. Reg. 375/92. Only when an entire regulation has been revoked will an entry appear in this manner. If in this instance, O. Reg. 375/92 not only revoked R.R.O. 1990, Reg. 1004, but also substituted new provisions for it, these new provisions would be indicated in a totally separate entry which would appear below the one illustrated.
