The book also contains minor updates about electronic signatures and whether notice is required when cases are flagged for fraud investigation at the Request for Hearing level. As for the major announcement in 2024 that the attorney fee cap would be tied to the cost-of-living-adjustment schedule, the book deals with the quiet change in plans. There is also a plan to change the way Continuing Disability Reviews will be conducted, taking this duty away from Disability Determination Services, and moving it to a new unit called the Disability Case Review Team.
