Michigan SCAO Approved Forms, **Volume 1 & 2, 2026 Edition**

Enclosed is the 2026 edition for Michigan SCAO Approved Forms. This enclosure replaces the 2025 edition of Volumes 1 & 2. Please note that, for ease of handling, the materials in this shipment may ship in more than one box.

This 2026 edition provides full-size forms approved by the State Court Administrative Office for use in Michigan courts, with new and amended forms received through July 28, 2026. Full-size 8 ½" x 11" perforated pages allow for removal of forms for photocopying. Each form starts on a new leaf to facilitate use of individual forms. The back sides of two-sided forms are printed upsidedown for "head-to-toe" reading when a form is incorporated into a court file.

Volume 1 includes District Court Forms, Circuit Court Forms, and Michigan Court Forms. Volume 2 includes Friend of the Court Forms; Circuit Court Family Division Miscellaneous Forms, Adoption Forms, and Juvenile Forms; Probate Court Forms; and Mental Health Treatment Forms.

- Added FOC 137 and FOC 138 to address amendments to MCR 3.207

- Revised several Circuit court forms and instructions to clarify information required for LEIN and NCIC entry
- Revised, added, and deleted many District court forms and added MC 500 as part of the small claims design-system update
- Revised MC 100 to conform to the exemption approval process of MCR 1.109(G)
- Deleted CC 401 as obsolete according to the Michigan Appellate Assigned Counsel System (MAACS)
- Reformatted many CC, CCFD, CIA, DC, and JC forms to align with updated design standards without substantive text changes
- Other recently amended forms
